

SICICLANDO Policies/Guest Terms and Conditions Reservations, Deposits, and Payments

We are pleased to take you on a Siciclando tour. To make a reservation, please complete the reservation form and return it by e-mail or facsimile. We require a 30% deposit of the tour cost to reserve your space. A deposit indicates your acceptance of our terms and conditions. The balance of the tour cost is due no later than 60 days before the tour departure. Once your full payment is received, we will send a comprehensive packet so you can prepare for your tour. Please, note that all Siciclando prices are in Euros. Any payment or refund will be calculated in this currency. Siciclando is not responsible for any currency rate changes. Once you have filled out the reservation form and we have contacted you about the deposit amount you have two payment options: 1) Credit card - You will receive a Paypal request by e-mail with instructions to pay the deposit or to pay the full tour price by credit card converted into British Pounds. You don't need to have a Paypal account for this transaction. If necessary, we will send another Paypal request for the balance owed, sixty days before your departure date. Please understand we will pass on a 2.5% fee for credit card costs. 2) Wire transfer - If you choose this payment option, we will provide you with instructions for the transaction. Please, be aware that most banks will charge an approximate €20 fee for each single wiring transaction, which will be included in your Siciclando charge.

Cancellation Policy

We understand that you may need to change your travel plans. If you are unable to take your tour with us after making a deposit or full payment, we will apply the following cancellation fee:

- 60 days or more before the tour departure date there will be a €150 administrative fee per person
- 45/60 days before the tour departure date: cancellation fee of 30% of tour cost per person
- 30/44 days before the tour departure date: cancellation fee of 50% of tour cost per person
- 15/29 days before the tour departure date: cancellation fee of 75% of tour cost per person
- 0/14 days before the tour departure date: cancellation fee of 100% of tour cost per person
- No refunds are possible after the tour begins. Please note that any refund from Siciclando will be done within 30 days after the end of the scheduled trip

 You also have the option of applying your deposit or payment to another Siciclando tour during the same season. Each tour is priced differently. Your deposit or payment will be applied to the new tour of your choice and the balance will be adjusted accordingly. In the unusual situation that Siciclando has to cancel a tour, you have the following options:
- Siciclando will refund the full deposit
- You can use the deposit for another Siciclando tour already confirmed during the same season
- Keep in mind that each tour is priced differently. Your deposit or payment will be applied to the new tour of your choice and the balance will be adjusted accordingly.
- You can run the trip as a self guided option, if the tour offers that option.
 SICICLANDO is not responsible for other expenses incurred such as non-refundable plane tickets, if a tour is cancelled.



Travel Insurance

Siciclando strongly encourages/highly recommends guests purchase sufficient travel insurance to cover travel cancellation or delays as well as, medical expenses, personal liability, and personal belongings during travel.
